Subject :- Order under Rule 7 (1) (k) of the Foreign Trade (Regulation) Rules, 1993, read with Sec. 9 of the Foreign Trade (Development & Regulation Act), 1992, as amended.

Whereas M/s. J. G. Chemicals Pvt. Ltd., 34-A, Metcalfe Street, Kolkata-700013 (hereinafter referred as the "the firm") was issued an Adv. Authorisation No. 0210204711 dated 05-08-14 for import of Zinc Dross/Score/Scrap As per ISRI Specification falling under ITC (HS) Code No.79020010 for a CIF Value of Rs. 45115083.00 (US \$ 877500.00) with an obligation to export of 500 MT of Zinc Oxide Purity 99.00% to 99.90% for FOB Value of Rs.70000000.00 (US \$ 1361517.00) as per SION Sl. No. 62/1206 within 18 months from the date of issue of the Authorization.

2. AND Whereas the export obligation period expired on 28-02-2016 but the firm failed to submit documents evidencing fulfillment of export obligation within the period as stipulated in the Condition Sheet annexed to the Authorization;

3. AND whereas Show Cause Notice was issued to the firm on 21-02-2018 in terms of Rule 7 (1) (k) of the Foreign Trade (Regulation) Rules, 1993, read with Section-9 of the F.T.D.R. Act, 1992 for non-fulfillment of export obligation and violation of the provisions of the Act and Rules asking them to submit the complete export documents with opportunity of Personal Hearing, but the firm failed to submit the complete export documents towards fulfillment of export obligation, nor availed the opportunity of Personal Hearing.

4. Now, therefore, the undersigned, in terms of the powers conferred under Section 9 of the FTDR Act, 1992 read with Rule 7 (1) (k) of the Foreign Trade (Regulation) Rules, 1993, as amended, hereby order denial of grant of any Authorization / Scripps or renewal of any Authorization to M/s. Amrit Exports Pvt. Ltd. With immediate effect till further order.

Whereas M/s. Ceratizit India Pvt. Ltd., (hereinafter referred as the "the firm") was issued an Adv. Authorisation No. 0210205397 dated 30-12-14 for import of Tungsten Carbide Mixed Powder various grade like – S 26T, U 17 T, H582, H216T, V 667, S40T, H70T, H740, H495, H60T, TW10, TW20, TW39, H718 etc. falling under ITC (HS) Code No.28499020 for a CIF Value of Rs. 14043737.70 (EURO 177433.20) with an obligation to export of 1800.00 KG of Tungsten Carbide Inserts for FOB Value of Rs. 18540000.00 (EURO 240000.00) as per SION Sl. No. 61/1613 within 18 months from the date of issue of the Authorization.

2. AND Whereas the export obligation period expired on 29-06-2016 but the firm failed to submit documents evidencing fulfillment of export obligation within the period as stipulated in the Condition Sheet annexed to the Authorization;

3. AND Show Cause Notice was issued to the firm on 19-01-2018 in terms of Rule 7 of the Foreign Trade (Regulation) Rules, 1993, read with Section-9 of the F.T.D.R. Act, 1992 for non-fulfillment of export obligation and violation of the provisions of the Act and Rules asking them to submit the export documents with opportunity of Personal Hearing, but the firm failed to submit export documents towards fulfillment of export obligation, nor availed the opportunity of Personal Hearing.

4. Now, therefore, the undersigned, in terms of the powers conferred under Section 9 of the FTDR Act, 1992 read with Rule 7.1 (k) of the Foreign Trade (Regulation) Rules, 1993, as amended, hereby order denial of grant of any Authorization / Scripps or renewal of any Authorization to M/s. Amrit Exports Pvt. Ltd. With immediate effect till further order.
